- Remove all exterior doors, supply and install 2 x exterior doors
- Close one entrance door
- Demolish all interior wall except for the office
- Supply and install one interior entrance door to the office
- Supply and install roof sheets (IBR)
- Supply and install 16 x planks (2 x 3 m)
- Exterior and interior painting
- Repainting of window frames
- Construction of the stage
- Wash exterior rough craft
- Supply and install ceiling board
- Supply and install 12 meters gutter with down pipe
- Supply and install water tank (2 000 liters)
- Construction of two gender ablution facility
